- If approved, I will need to read, and sign, the Foster Care Agreement.
- If approved, I will discuss all specifics with a FHAC representative.
- The foster agreement may be terminated by either party at any time. Upon termination, all foster animals in your care must be returned to Furever Home Adoption Center, Inc.
